Product description

Chipotle peppers in adobo sauce come from ripe, smoked jalapeno peppers that are hydrated with water, packed in hermetically sealed containers with tomato sauce and thermally processed. All equipment and processes involved in the elaboration of the product comply with strict hygienic conditions and with all current and applicable legislation on Good Manufacturing Practices and the BRCGS Food Safety Standard.

Chipotle peppers, water, tomato paste, salt, sugar, onion, acetic acid (acidity regulator E260).
